The products manufactured by the company mentioned above are board grades coated with polyethylene, which are used for food packaging.

They were examined by us according to the

Series of standards EN 1186, EN 13130 and CEN/TS 14234 "Materials and Articles in Contact with Foodstuffs – Plastics", current state,

for the migration behaviour.

Furthermore, the board grades were tested for limited heavy metals according to the

Regulation (EU) 2025/40 of the European Parliament and of the Council of 19 December 2024 on packaging and packaging waste, amending Regulation (EU) 2019/1020 and Directive (EU) 2019/904, and repealing Directive 94/62/EC, Official Journal of the European Union L, 2025/40, 22.1.2025, Article 5,

as well as to the

Model Toxics in Packaging Legislation as developed by the Source Reduction Council of CONEG of December 14, 1989, last modified in February 2021.

The board grades are in compliance with the rules of the

Regulation (EC) No 1935/2004 of the European Parliament and of the Council of 27 October 2004 on materials and articles intended to come into contact with food and repealing Directives 80/590/EEC and 89/109/EEC, Official Journal of the European Union L 338/4 of 13.11.2004, lastly modified by article 5 of the Regulation (EU) 2019/1381 of 20 June 2019, Official Journal of the European Union L 231/1 of 6 September 2019, article 3, 1. (a) and (b),

as well as of the

With regard to the content of heavy metals, the board grades also meet the requirements of the

Regulation (EU) 2025/40 of the European Parliament and of the Council of 19 December 2024 on packaging and packaging waste, amending Regulation (EU) 2019/1020 and Directive (EU) 2019/904, and repealing Directive 94/62/EC, Official Journal of the European Union L, 2025/40, 22.1.2025, Article 5,

as well as the

Model Toxics in Packaging Legislation as developed by the Source Reduction Council of CONEG of December 14, 1989, last modified in February 2021.

Thus the board grades in all combinations **Multiboard + Transparent LDPE**, **Multiboard + White LDPE**, **Multiboard + Brown LDPE** and **Multiboard + Transparent HDPE** according to the sample material submitted may be used safely for food packaging, namely for the packaging of frozen food products. They may also be used in the fast food area and in the take-away area for food which may also be heated up to a temperature of 90 °C for a short period of time and may stand in direct contact with aqueous, non-acidic (pH > 4.5) and fatty food with their coated side. Additionally the use of the board grades in the area of the packaging of dry, non-fatty pet food is possible.

This certificate of compliance has a validity of 2 years and consists of 4 pages.
